**Mandatory by February 1** Minimum Deposit of \$1,000 per person and/or seat is required to reserve your blind and/or seat for the upcoming season. All seats in each blind must have this deposit paid to secure the blind for the upcoming season.

**Duck blind Fees: \$1,000 – Mandatory Balance Due Payment by April 30**

**No deposits or membership fees will be refunded after April 30 unless approved by BCHC board.**

**If payment has not been made in full by May 15<sup>th</sup> your deposit, blind and/or seat will be forfeited. Your blind and/or seat will be available to others.**

Membership includes the usage of all club facilities: clubhouse, bunkhouse, showers and washroom, portable toilets, and picking shed. All of these are first-come, first-serve basis. All rules, regulations, and procedures of the Butte City Hunting Club apply. Fish and Game rules and regulations are strictly enforced. Seasonal Membership is from the beginning of Dove Season thru the end of the corresponding Duck Season.

**Trailer Parking:** 3<sup>rd</sup> Saturday of October until 2 weeks after end of waterfowl season. **No Hookups.**
